Plaintiff Trisha Teperson ("Plaintiff") brings this action, on behalf of herself and all others similarly
 situated, against Defendants Nogin, Inc. ("Nogin"), Justice Brands Holdings, LLC ("Justice"), Bluestar
 Alliance, LLC ("Bluestar"), B. Riley Securities, Inc. ("B. Riley Securities"), and B. Riley Principal
 Investments, LLC ("B. Riley Principal") (collectively, "Defendants"), and states:

I. NATURE OF THE ACTION

American consumers thrive on finding the best deal. Retailers, including Defendants, are
 keen to this fact and try to lure consumers to purchase their goods with advertised sales that promise huge
 savings off the regular price. But the promised savings are false if a retailer simply recasts its regular price
 as a discount from some higher, fictitious "original" price that no one ever pays. This class action seeks
 monetary damages, restitution, declaratory and injunctive relief from Defendants arising from its deceptive
 business practice of advertising fictitious reference prices and corresponding phantom discounts on its e commerce website shopjustice.com.

2. The practice of false reference pricing occurs when a retailer fabricates a false "original"
price, and then offers an item for sale at a deeply "discounted" price. The result is a sham price disparity
that misleads consumers into believing they are receiving a good deal and induces them into making a
purchase. In reality, the practice artificially inflates the true market price for these items by raising
consumers' internal reference price, and therefore the value, ascribed to these products by consumers. The
practice enables retailers, like Defendants, to sell their goods above their true market price. Consumers are
damaged by the inflated market price that is established by the false-discounting scheme.

3. An overview of the illegal scheme and attendant harm is best demonstrated by the following 20example: Take a retailer who is in the business of selling suits. That retailer knows it can sell a particular 21 suit for \$250.00. That \$250.00 price represents the "market" price for the suit and the price at which the 22 retailer regularly offers the suit for sale and makes a profit. The retailer then offers the suit on sale. 23 However, instead of discounting the suit from its true original price of \$250.00, the retailer utilizes an 24 inflated, "original" price for the suit and lists it at \$1,000.00, and then holds it out for sale at 70% off-25 rendering the "sale" price of the suit \$300.00. Consumers who happen upon that purported fake "sale" are 26 influenced by the amount of the perceived, substantial discount. By presenting the consumer with a false 27 "original" price of \$1,000.00, the retailer has increased demand for the suit through the perceived value of 28

both the suit itself and the substantial discount of \$700.00. This effect, in turn, impacts the market price 1 of the suit because more consumers are willing to pay \$300.00 for a suit they believed was once sold for 2 3 \$1,000.00, when, in fact, the true market price of the suit, without the false discount, was \$250.00. If the retailer tried to sell that same suit, for \$300.00, without offering the false original price of \$1,000.00 and 4 the attendant 70% discount, that retailer would not be able to sell any suits at \$300.00 because the true 5 market price of the suit is \$250.00. Thus, through the use of a false original price and the corresponding 6 7 phantom discount of 70% off, the retailer was able to create a false "market" price for the suit-at \$300.00. Plaintiff's case seeks that disparity—the impact of the increase in market price from \$250.00 to \$300.00 8 through the Defendants' application of an illegal discounting scheme. 9

4. Retailers, including Defendants, substantially benefit from employing false reference
pricing schemes and experience increased sales because consumers use advertised reference prices to make
purchase decisions. The information available to consumers varies for different types of products, but
consumers frequently lack full information about a product and, as a result, can incorporate information
from sellers to make purchase decisions.

5. Through its false and misleading marketing, advertising, and pricing scheme alleged herein, 15 Defendants violated, and continues to violate, California and federal law, which prohibits the advertisement 16 of goods for sale discounted from former prices that are false. California and federal law also prohibit the 17 18 dissemination of misleading statements about the existence and amount of price reductions. Specifically, Defendants violated, and continues to violate: California's Unfair Competition Law, Business and 19 Professions Code section 17200 et seq. (the "UCL"); California's False Advertising Law, Business and 20 Professions Code section 17500 et seq. (the "FAL"); the California Consumer Legal Remedies Act, Civil 21 Code section 1750 et seq. (the "CLRA"); and the Federal Trade Commission Act ("FTCA"), which 22 23 prohibits "unfair or deceptive acts or practices in or affecting commerce" (15 U.S.C. § 45(a)(1)) and false advertisements (15 U.S.C. § 52(a)). 24

6. Plaintiff brings this action on behalf of herself and other similarly situated consumers who
have purchased one or more products from Defendants' e-commerce website shopjustice.com that were
deceptively represented as discounted from a false reference price. Plaintiff seeks to halt the dissemination
of this false, misleading, and deceptive pricing scheme, to correct the false and misleading perception it

1 has created in the minds of consumers, and to obtain redress for those who have purchased merchandise 2 tainted by this deceptive pricing scheme. Plaintiff also seeks to enjoin Defendants from using false and 3 misleading misrepresentations regarding former price comparisons in their labeling and advertising permanently. Further, Plaintiff seeks to obtain damages, restitution, and other appropriate relief in the 4 5 amount by which Defendants were unjustly enriched as a result of its sales of merchandise offered at a false discount. 6

7 7. Finally, Plaintiff seeks reasonable attorneys' fees pursuant to Civil Procedure Code 8 section 1021.5, as this lawsuit seeks the enforcement of an important right affecting the public interest and 9 satisfies the statutory requirements for an award of attorneys' fees.

П. JURISDICTION AND VENUE

8. Plaintiff is informed and believes that Defendants are business entities that conducts 11 business in the State of California. Defendants has operated their e-commerce website shopjustice.com 12 throughout California, including the County of San Diego, which has caused both obligations and liability 13 of Defendants to arise in the County of San Diego. 14

9. This Court has jurisdiction over Defendants and the claims set forth below pursuant to Civil 15 Procedure Code section 410.10 and the California Constitution, Article VI section 10, because this case is 16 a cause not given by statute to other trial courts. Additionally, Plaintiff resides in the County of San Diego. 17 10.

III. GENERAL ALLEGATIONS

The amount in controversy exceeds the jurisdictional minimum of this Court.

А. **Retailers Benefit from False Reference Pricing Schemes.**

11. Defendants engage in a false and misleading reference price scheme in the marketing and 21 selling of their products on its e-commerce website shopjustice.com. 22

12. Retailers substantially benefit from employing false reference pricing schemes, and 2324 experience increased sales because consumers use advertised reference prices to make purchase decisions. The information available to consumers varies for different types of products.¹ Nonetheless, consumers 25

frequently lack fundamental information about a product and, as a result, often rely on information from 1 2 sellers to make purchase decisions, especially when a product's value or quality is otherwise difficult to discern.² 3

13. Defendants' deceptive advertised reference prices are thus incorporated into the consumer's 4 decision process. First, a product's "price is also used as an indicator of product quality."³ In other words, 5 consumers view Defendants' deceptive advertised reference prices as a proxy for product quality. Second, 6 reference prices "appeal[] to consumers' desire for bargains or deals."⁴ Academic researchers note how 7 consumers "sometimes expend more time and energy to get a discount than seems reasonable given the 8 financial gain involved," and "often derive more satisfaction from finding a sale price than might be 9 expected on the basis of the amount of money they actually save."⁵ Under this concept, coined as 10 "transaction utility" by Nobel Prize-winning economist Richard Thaler, consumers place some value on 11 the psychological experience of obtaining a product at a perceived bargain.⁶ 12

15

14. Research in marketing and economics has long recognized that consumer demand can be

influenced by "internal" and "external" reference prices.⁷ Internal reference prices are "prices stored in 14

1	memory" (e.g., a consumer's price expectations adapted from past experience), while external reference										
2	prices are "provided by observed stimuli in the purchase environment" (e.g., a "suggested retail price," or										
3	other comparative sale price). ⁸ Researchers report that consumer's internal reference prices adjust toward										
4	external reference prices when valuing a product. ⁹ For infrequently purchased products, external reference										
5	prices can be particularly influential because these consumers have little or no prior internal reference. ¹⁰										
6	In other words, "[t]he deceptive potential of such advertised reference prices are likely to be considerably										
7	higher for buyers with less experience or knowledge of the product and product category." ¹¹ Academic										
8	literature further reports that "there is ample evidence that consumers use reference prices in making brand										
9	choices" ¹² and publications have summarized the empirical data as follows:										
10	Inflated reference prices can have multiple effects on consumers. They can increase consumers' value perceptions (transaction value and acquisition value), reduce their search										
11	intentions for lower prices, increase their purchase intentions, and reduce their purchase intentions for competing products Inflated and/or false advertised reference prices										
12	enhance consumers' internal reference price estimates and, ultimately, increase their perceptions of value and likelihood to purchase[.] ¹³										
13	perceptions of value and intenniood to purchase[.]										
14	15. Retailers, including Defendants, understand that consumers are susceptible to a good										
15	bargain, and therefore, Defendants have a substantial financial interest in making the consumer believe										
16	they are receiving a good bargain, even if they are not. A product's reference price matters to consumers										
17	because it serves as a baseline upon which consumers perceive a product's value.

B. California State and Federal Pricing Regulations Prohibit False "Original Price" References and Out-Dated "Original Price" References.

3 16. Under California law, a retailer may only discount an item from its own original price for up to 90 days, or in the alternative, it may offer a discount from the original price of an item being offered 4 5 by a competitor, within the relevant market, for up to 90 days. In either scenario, a retailer can only offer a "sale" from an original price for 90 days. At that point, on day 91, the retailer has two options: the 6 7 product must either return to its full original price, or the retailer may continue to sell the product at the discounted price, as long as it discloses to the consumer the date on which the product was last offered 8 for sale at its full retail price. (See Bus. & Prof. Code, § 17501.) Under California law, a retailer cannot 9 10 use an old, outdated, "original price" as the basis for a sale or discount, unless it discloses to the consumer the date on which the prior original price was offered in the market. 11

12 17. Additionally, under the FCTA, when a retailer offers a discount from <u>its own</u>, former
13 original price, the original price is required to have been a price at which <u>the retailer</u> held that item out
14 for sale <u>on a regular basis</u>, for a <u>commercially reasonable period of time</u>. (See 16 C.F.R. § 233.1(a) &
15 (b) (italics added).)

Defendants' Fraudulent Price Discounting Scheme Violates California State and Federal Regulations.

18. Defendants engages in a false and misleading reference price scheme in the marketing and 18 19 selling of the products offered on its e-commerce website. Defendants advertise girls' apparel, accessories, and other related items for sale by listing them with a fictitious original price and a corresponding sale 20price. The original price communicates "the product's worth and the prestige that ownership of the product 21 conveys." (See Hinojos v. Kohl's Corp. (9th Cir. 2013) 718 F.3d 1098, 1106 [citing Dhruv Grewal & Larry 22 23 D. Compeau, Comparative Price Advertising: Informative or Deceptive?, (Spring 1992) 11 J. Pub. Pol'y & Mktg. 52, 55 ("By creating an impression of savings, the presence of a higher reference price enhances 24 subjects' perceived value and willingness to buy the product.")].) "Misinformation about a product's 25 'normal' price is...significant to many consumers in the same way as a false product label would be." 26 (Ibid.) 27

28

19. Defendants consistently advertise its products on its e-commerce website shopjustice.com

alongside a higher "original" price, and the corresponding sale price. Defendants advertise a seemingly
original price, in truth a false reference price, with a "strikethrough," which suggests to customers that
Defendants previously offered its products at the strikethrough price. The false reference price operates as
a baseline consumers rely on to assess a product's value. Moreover, it is shown next to the "sale" price to
communicate to consumers that Defendants are selling a product at a substantial discount, even though the
product is not in fact discounted. The sale price displayed directly next to the false reference price conveys
the "deep discount" at which Defendants presently offer a product, ostensibly for a limited time.

8 20. However, the products sold on Defendants' e-commerce website are never sold at the price 9 consumers are led to presume is the full original price—the price displayed with a strikethrough next to 10 the "sale" price. The "deep discount" of products communicated to consumers viewing Defendants' e-11 commerce website constitutes a misrepresentation by Defendants. The "original" price communicated by 12 Defendants merely serves as a false reference price Defendants use as part of a larger scheme to deceptively 13 manufacture false discounts to incentivize consumers to make purchases.

14 21. Defendants' purposeful practice operates by deceiving consumers into (1) making
15 purchases they otherwise would not have made and (2) paying substantially more for products they
16 believed are heavily discounted and thus worth more than their actual value. The only plausible explanation
17 for Defendants' above illustrated practice is to drive sales, artificially inflate the perceived value of its
18 products, and, as a result, artificially inflate the price at which consumers are willing to buy its products.
19 Defendants have, and without intervention will continue to, increase sales by creating the illusion of short20 lived bargains by purporting to offer products on sale from false original prices.

21 22. Defendants' perpetual listings of its products as discounted on its e-commerce website
22 shopjustice.com constitutes false, fraudulent, and deceptive advertising because the advertised reference
23 prices the website displays list substantially higher prices than those ever offered by Defendants. The
24 communicated reference prices only serve to deceive consumers; they function as benchmark prices from
25 which the false discount and corresponding "sale" price are derived. Defendants' scheme tricks consumers
26 into justifiably believing they are getting a significant deal when in reality consumers are paying the usual
27 retail price for products.

28

23. In sum, the false reference prices, the strikethrough of said prices, and the sale prices

displayed next to each other on product listing pages on Defendants' e-commerce website shopjustice.com 1 are all part of Defendants' purposeful, deceptive scheme. The products sold through Defendants' e-2 3 commerce website shopjustice.com are never offered for sale, nor sold, at the advertised false reference price. Defendants advertise false reference prices with the purpose of inducing consumers into believing 4 5 its products were once sold at said price. The strikethrough of the false reference prices next to products 6 creates a false sense of urgency in consumers. Defendants intend for consumers to be misled that 7 Defendants will sell its products at the advertised, higher reference price "again" if they do not purchase 8 its products soon; and consumers are misled. Consumers believe they are receiving a substantial bargain 9 when they purchase products on Defendants' e-commerce website at the "discounted" sale price. However, 10 Defendants did not actually sell products on its e-commerce website shopjustice.com at the advertised reference prices within 90 days of discounting them. In fact, Defendants never offered or sold products at 11 their advertised false reference price, and consumers thus never received a true bargain. All while fully 12 13 aware of its deception, Defendants have achieved, and might continue to achieve, its ultimate, continuing purpose of driving sales with sham markdowns. 14

15 24. Nowhere on Defendants' e-commerce website do Defendants disclose that the reference or
16 "original" prices are not: former prices; or recent, within 90 days, regularly offered former prices; or prices
17 at which identical products are sold elsewhere in the market. The omission of these disclosures, coupled
18 with Defendants' use of fictitious advertised reference prices, renders Defendants' pricing scheme
19 inherently misleading.

20 25. Moreover, the advertised discounts were fictitious because the reference prices did not
21 represent a *bona fide* price at which Defendants previously sold or offered to sell the products, on a regular
22 basis, for a commercially reasonable period of time, as required by the Federal Trade Commission ("FTC").
23 In addition, the represented advertised reference prices were not the prevailing market retail price within
24 the three months (90 days) immediately preceding the publication of the advertised former reference price,
25 as required by California law.

26 26. Thus, Defendants' scheme intends to, and does, provide misinformation to the customer.
27 This misinformation communicates to consumers, including Plaintiff, that the products sold on Defendants'
28 e-commerce website have greater value than the advertised discounted price.

27. The reference prices listed and advertised on products sold through Defendants' e commerce website are false or severely outdated reference prices, utilized only to perpetuate Defendants'
 false discount scheme.

4 28. Defendants know that its reference price advertising is false, deceptive, misleading, and 5 unlawful under state and federal law.

6 29. Defendants fraudulently concealed from, and intentionally failed to disclose to, Plaintiff
7 and other members of the Class, the truth about its advertised discount prices and former reference prices.

8 30. At all relevant times, Defendants have been under a duty to Plaintiff and the Class to
9 disclose the truth about its false discounts.

10

D. Investigation

11 31. Products sold on Defendants' website, shopjustice.com, are priced uniformly. In other 12 words, the products sold by Defendants bear a substantially discounted sale price that appears next to the 13 "crossed out" or "strikethrough" original price. Plaintiff's counsel's investigation confirmed that the 14 merchandise purchased by Plaintiff was priced with a false reference price and a corresponding discounted 15 price for at least the 90-day period immediately preceding Plaintiff's purchase in violation of California 16 law. The product purchased by Plaintiff was not, and is not, offered for sale in any other market.

32. 17 Plaintiff's counsel conducted a thorough investigation of Defendants' website. Plaintiff's 18 counsel deployed a sophisticated software program to track each item offered for sale on the shopjustice.com website. Plaintiff's counsel tracked the pricing of certain merchandise offered for sale 19 through shopjustice.com for various periods from 2022 through the present. A sample of the items tracked 20 are attached as Exhibit A. For the duration of the tracking period, each product remained significantly 21 22 discounted from its reference price. Plaintiff's counsel's investigation revealed that approximately 680 23 items on shopjustice.com were on sale for more than 100 days as of, on or around, July 30, 2022. The 24 investigation indicated the false reference pricing scheme was uniform across Defendants' e-commerce 25 website.

33. The false reference price and corresponding discount price scheme were both uniform and
identical on all products sold through Defendants' e-commerce website.

34.

Thus, the fraudulent price scheme applies to all products offered for sale through

Defendants' e-commerce website, including the product purchased by Plaintiff.

IV. PARTIES

Plaintiff

35. Plaintiff Trisha Teperson resides in San Diego County, California. Plaintiff, in reliance on Defendants' false and deceptive advertising, marketing and discounting pricing schemes, purchased the following item online from San Diego County, California on September 14, 2022:

36. Plaintiff examined the above-listed product on Defendants' website before deciding to
purchase the aforementioned product after reviewing the item's advertised sale price. The item Plaintiff
purchased was advertised as having an original price that was more than the sale price displayed on the
website. Defendants advertised the item as having a sale price at a discount.

37. After observing the original price of the "Patterned Shorts Pajama Set" with a strikethrough,
and the accompanying sale price itself, Plaintiff believed she was receiving a significant discount on the
product she had chosen. Because she was interested in the product and felt that the discounted price would
likely not last, and that she was getting a significant bargain on the product, Plaintiff proceeded to finish
checking out and purchased it.

19 38. However, this product was never offered for sale at the original price communicated on
20 Defendants' e-commerce website and certainly not within the 90 days preceding Plaintiff's purchase.
21 Neither Plaintiff's receipt nor any other language on the website observed or relied upon by Plaintiff
22 indicated that the product was not offered previously at the reference price.

23 24

39. Plaintiff reasonably relied upon Defendants' artificially inflated reference prices and false discounts when purchasing the aforementioned product from Defendants' e-commerce website. Plaintiff would not have made such a purchase but for Defendants' representations regarding the substantial discount being offered for the product. Plaintiff would like to continue buying from Defendants' e-commerce website in the future but cannot be certain of the veracity of Defendants' advertised bargains.

28 ||

40. Plaintiff and the Class reasonably and justifiably acted and relied on the substantial price

differences that Defendants advertised, and they made purchases believing they were receiving a
 substantial discount on a product of greater value than the value it had in actuality. Plaintiff, like other
 Class members, was lured in, relied on, and was damaged by the deceptive pricing scheme Defendants
 carried out.

5 41. Plaintiff was damaged in her purchase because Defendants' false reference price discounting scheme inflated the true market value of item she purchased. Plaintiff is susceptible to this 6 reoccurring harm because she cannot be certain that Defendants have corrected this deceptive pricing 7 8 scheme and she desires to shop at Defendants' shopjustice.com website in the future. However, she 9 currently cannot trust that Defendants will accurately price their products truthfully and in a nonmisleading fashion in compliance with applicable law. Plaintiff does not have the resources on her own to 10 determine whether Defendants are complying with State and Federal law with respect to its pricing 11 12 practices.

42. Additionally, because of the variety of merchandise available on Defendants' website, and 13 due to the likelihood that Defendants may yet develop and market additional falsely priced items for sale 14 15 online, Plaintiff may again, though by mistake, purchase a falsely discounted item from Defendants under the impression that the advertised reference price represented a *bona fide* former price at which the item 16 was previously offered for sale by Defendants. Indeed, Plaintiff desires to continue purchasing products 17 18 from shopjustice.com in the future. Moreover, Class members will continue to purchase products from 19 shopjustice.com while reasonably but incorrectly believing that their advertised reference prices represent bona fide former prices at which they were previously offered for sale by Defendants. 20

43. Absent an equitable injunction enjoining Defendants from continuing in the unlawful course 21 of conduct alleged herein, Plaintiff, Class members and the public will be irreparably harmed and denied 22an effective and complete remedy because they face a real and tangible threat of future harm emanating 2324 from Defendants' ongoing conduct that cannot be remedied with monetary damages. Accordingly, Plaintiff, Class members, and the general public lack an adequate remedy at law and an injunction is the 2526 only form of relief which will guarantee Plaintiff and other consumers the appropriate assurances. Moreover, Plaintiff lacks an adequate remedy at law with respect to her claim for equitable restitution 27 28 because she has not yet retained an expert to determine whether an award of damages can or will adequately

remedy her monetary losses caused by Defendants. Particularly, as legal damages focus on remedying the
 loss to the plaintiff and equitable restitution focuses wholly distinctly on restoring monies wrongly acquired
 by the Defendants, legal damages are inadequate to remedy Plaintiff's losses because Plaintiff does not
 know at this juncture, and is certainly not required to set forth evidence, whether a model for legal damages
 (as opposed to equitable restitution) will be viable or will adequately compensate Plaintiff's losses.

6 44. Finally, Plaintiff's case is substantially predicated on Defendants' violation of Business and 7 Professions Code section 17501, an equitable claim, as Plaintiff's counsel's investigation revolved around 8 ensuring that Defendants did not sell products at the indicated reference price within the 90 days preceding Plaintiff's purchase and, likewise, that Defendants failed to disclose to consumers the date on which 9 10 products were last offered at their advertised reference price. This claim and test of liability go to the heart of Plaintiff's case and the same test is not available under a CLRA legal claim for damages. Thus, Plaintiff 11 12 does not have an adequate remedy at law because the CLRA does not provide the same metric of liability as Business and Professions Code section 17501, which is integral not only to Plaintiff's prayer for 13 14 restitution, but also to Plaintiff's very theory of liability at trial.

15

Defendants

16 45. Defendant Nogin Inc. is incorporated in Delaware with its principal executive offices in 17 Tustin, California. Plaintiff is informed and believes that Defendant Nogin provides operational support 18 for the shopjustice.com website, and advertises, markets, distributes, and/or sells girls' apparel and 19 accessories in California and throughout the United States. In a May 2023 investor presentation, 20 shopjustice (under the brand name Justice) is listed as one of "Nogin's valued customers."¹⁴ It was reported 21 in July of 2021 that Justice moved its online store to Nogin's "platform."¹⁵

46. Defendant Bluestar Alliance, LLC is a New York Limited Liability Company with its
principal executive offices in New York, New York. Plaintiff is informed and believes that Defendant fully
owns Justice Brand Holdings, LLC, which in turn fully owns the Justice brand and shopjustice.com.

Defendant Bluestar Alliance, LLC purchased Justice Brand Holdings LLC from Ascena Retail Group in
 November of 2020.¹⁶ Justice is listed as one of Bluestar Alliance, LLC's "Brands" on its website.¹⁷
 Bluestar Alliance acquired the intellectual property of the Justice Brand through a newly established entity,
 Defendant Justice Brand Holdings, LLC.¹⁸

47. Defendant Justice Brand Holdings, LLC is a New York Limited Liability Company with its 5 6 principal executive offices in New York, New York. Plaintiff is informed and believes that Defendant Justice Brand Holdings, LLC fully owns the Justice brand; and, in turn, Defendant Bluestar Alliance, LLC 7 8 fully owns Defendant Justice Brand Holdings, LLC. On shopjustice.com, the bottom of the webpage states that "[t]he JUSTICE® trademarks, name and logos are owned by Justice Brand Holdings LLC."¹⁹ In 9 addition, the website justiceretail.com also states that "Justice is now owned and operated by Justice Brand 10 Holdings LLC."²⁰ Thus. Plaintiff is informed and believes that Defendant Justice Brand Holdings, LLC 11 operates the shopjustice.com website, and advertises, markets, distributes, and/or sells girls' apparel and 12 13 accessories in California and throughout the United States.

48. Defendant B. Riley Securities, Inc. is a Delaware corporation with its principal executive
offices in Los Angeles, California. Plaintiff is informed and believes that Defendant B. Riley Securities
provided Defendant Nogin, Inc. with a promissory note on November 16, 2023; the note came with a
security interest in "all right, title and interest in certain of each grantor's assets..."²¹ Plaintiff is informed
and believes that this grants Defendant B. Riley Securities a security interest in Defendant Nogin, and thus
its liability in connection with the claims alleged herein.

2049. Defendant B. Riley Principal Investments, LLC is a Delaware Limited Liability Corporation21with its principal place of business in Delaware. Plaintiff is informed and believes that Defendant B. Riley

Principal has a security interest in Nogin through the provision of a debtor-in-possession loan, which has
 been or very shortly will be combined with the promissory note from Defendant B. Riley Securities, which
 would then be "equitized into 100% ownership of Nogin or be used to acquire substantially all of Nogin's
 assets."²² Thus, on Plaintiff's information and belief, Defendants B. Riley Securities and B. Riley Principal
 have a 100% ownership interest in Defendant Nogin, Inc.

50. Plaintiff does not know the true names or capacities of the persons or entities sued herein
as Does 1-50, inclusive, and therefore sue such Defendants by such fictitious names. Plaintiff is informed
and believes, and upon such information and belief alleges, that each of the Doe Defendants are in some
manner legally responsible for the damages suffered by Plaintiff and the Class members as alleged herein.
Plaintiff will amend this Complaint to set forth the true names and capacities of these Defendants when
they have been ascertained, along with appropriate charging allegations, as may be necessary.

V. CLASS ALLEGATIONS

13 51. Plaintiff brings this action on behalf of herself and all other similarly situated Class
14 members pursuant to California Code of Civil Procedure Section 382 on behalf of herself and seeks
15 certification of the following Class against Defendants for violations of California state laws:

All persons who, within the applicable statutory period (the "Class Period"), purchased from Defendants' e-commerce website shopjustice.com one or more products at discounts from an advertised reference price and who have not received a refund or credit for their purchase(s).

Excluded from the Class are Defendants, as well as its officers, employees, agents or affiliates, parent
companies and/or subsidiaries, and each of their respective officers, employees, agents or affiliates, and
any judge who presides over this action. Plaintiff reserves the right to expand, limit, modify, or amend this
Class definition, including the addition of one or more subclasses, in connection with her motion for Class
certification, or at any other time, based upon, *inter alia*, changing circumstances and/or new facts obtained
during discovery.

52. *Numerosity*: The Class members are so numerous that joinder of all members is impracticable. Plaintiff is informed and believes that the proposed Class contains hundreds of thousands

of individuals who have been damaged by Defendants' conduct as alleged herein. The precise number of Class members is unknown to Plaintiff.

53. Existence and Predominance of Common Questions of Law and Fact: This action involves common questions of law and fact, which predominate over any questions affecting individual Class members. These common legal and factual questions include, but are not limited to, the following:

a. whether, during the Class Period, Defendants used falsely advertised reference prices on its products sold through its e-commerce store;

b. whether, during the Class Period, the reference prices advertised by Defendants were the prevailing market prices for the products in question during the three-month period preceding the dissemination and/or publication of the advertised former prices;

c. whether Defendants' alleged conduct constitutes violations of the laws asserted;

d. whether Defendants engaged in unfair, unlawful and/or fraudulent business practices under the laws asserted;

e. whether Defendants engaged in false or misleading advertising;

15
f. whether Plaintiff and Class members are entitled to damages and/or restitution and
the proper measure of that loss;

g. whether an injunction is necessary to prevent Defendants from continuing to use
false, misleading or illegal price comparison; and

h. whether Plaintiff and the Class are entitled to an award of reasonable attorneys' fees,
 interest, and costs of suit.

54. *Typicality*: Plaintiff's claims are typical of the claims of the Class members because, *inter alia*, all Class members have been deceived (or were likely to be deceived) by Defendants' false and
deceptive price advertising scheme, as alleged herein. Plaintiff is advancing the same claims and legal
theories on behalf of himself and all Class members.

25 55. Adequacy: Plaintiff will fairly and adequately protect the interests of the Class members.
26 Plaintiff has retained counsel experienced in complex consumer class action litigation, and Plaintiff intends
27 to prosecute this action vigorously. Plaintiff has no antagonistic or adverse interest to those of the Class.

56. Superiority: The nature of this action and the nature of laws available to Plaintiff and the 1 2 Class make the use of the class action format a particularly efficient and appropriate procedure to afford 3 relief to her and the Class for the wrongs alleged. The damages or other financial detriment suffered by individual Class members is relatively modest compared to the burden and expense that would be entailed 4 5 by individual litigation of their claims against Defendants. It would thus be virtually impossible for 6 Plaintiff and Class members, on an individual basis, to obtain effective redress for the wrongs done to them. Absent the class action, Class members and the general public would not likely recover, or would 7 8 not likely have the chance to recover, damages, restitution, or injunctive relief and Defendants will be permitted to retain the proceeds of their fraudulent and deceptive misdeeds. 9

57. All Class members, including Plaintiff, were exposed to one or more of Defendants' 10 misrepresentations or omissions of material fact claiming that former reference prices and advertised prices 11 12 were legitimate. Due to the scope and extent of Defendants' consistent false sale prices and advertising 13 scheme, disseminated in a years-long campaign to California consumers, it can be reasonably inferred that such misrepresentations or omissions of material fact were uniformly made to all members of the Class. 14 15 In addition, it can be reasonably presumed that all Class members, including Plaintiff, affirmatively acted in response to the representations contained in Defendants' false advertising scheme when purchasing 16 17 merchandise sold at Defendants' e-commerce website.

18 58. Plaintiff is informed that Defendants keeps extensive computerized records through its
19 online sales data, as well as through, *inter alia*, general marketing programs. Defendants have one or more
20 databases through which a significant majority of Class members may be identified and ascertained, and
21 they maintain contact information, including email and home addresses, through which notice of this action
22 could be disseminated in accordance with due process requirements.

VI. CAUSES OF ACTION

23

FIRST CAUSE OF ACTION

Violation of California's Unfair Competition Law ("UCL") Business and Professions Code section 17200 et seq.

27 59. Plaintiff repeats and re-alleges the allegations contained in every preceding paragraph as if
28 fully set forth herein.

60. Plaintiff brings this claim individually and on behalf of the members of the proposed Class against Defendants for violations of the UCL, Business and Professions Code section 17200 et seq.

61. The UCL defines "unfair business competition" to include any "unlawful, unfair or fraudulent" act or practice, as well as any "unfair, deceptive, untrue or misleading" advertising. (Bus. & Prof. Code, § 17200.)

6 62. The UCL imposes strict liability. Plaintiff need not prove that Defendants intentionally or
7 negligently engaged in unlawful, unfair, or fraudulent business practices—but only that such practices
8 occurred. (See Cortez v. Purolator Air Filtration Products Co. (2000) 23 Cal.4th 163, 181.)

"Unfair" Prong

10 63. A business act or practice is "unfair" under the UCL if it offends an established public
11 policy or is immoral, unethical, oppressive, unscrupulous or substantially injurious to consumers, and that
12 unfairness is determined by weighing the reasons, justifications and motives of the practice against the
13 gravity of the harm to the alleged victims.

14 64. Defendants' actions constitute "unfair" business practices because, as alleged above,
15 Defendants engaged in misleading and deceptive price comparison advertising that represented false
16 reference prices and corresponding deeply discounted phantom "sale" prices. Defendants' acts and
17 practices offended an established public policy of transparency in pricing, and engaged in immoral,
18 unethical, oppressive, and unscrupulous activities that are substantially injurious to consumers.

19 65. The harm to Plaintiff and Class members outweighs the utility of Defendants' practices.
20 There were reasonably available alternatives to further Defendants' legitimate business interests other than
21 the misleading and deceptive conduct described herein.

"Fraudulent" Prong

66. A business act or practice is "fraudulent" under the UCL if it is likely to deceive members
of the consuming public.

25 67. Defendants' acts and practices alleged above constitute fraudulent business acts or
26 practices, as they deceived Plaintiff and are highly likely to deceive members of the consuming public.
27 Plaintiff relied on Defendants' fraudulent and deceptive representations regarding their false reference
28 prices and corresponding phantom discounts on products sold at Defendants' e-commerce website

shopjustice.com. These misrepresentations played a substantial role in Plaintiff's decision to purchase
 those products at purportedly steep discounts, and Plaintiff would not have purchased those products
 without Defendants' misrepresentations.

"Unlawful" Prong

68. A business act or practice is "unlawful" under the UCL if it violates any other law or

6 | regulation.

69. Defendants' acts and practices alleged above constitute unlawful business acts or practices as
they have violated state and federal law in connection with their deceptive pricing scheme. The FTCA
prohibits "unfair or deceptive acts or practices in or affecting commerce" (15 U.S.C. § 45(a)(1)) and prohibits
the dissemination of any false advertisements. (15 U.S.C. § 52(a).) Under the FTC, false former pricing
schemes, similar to the ones implemented by Defendants, are described as deceptive practices that would
violate the FTCA:

(a) One of the most commonly used forms of bargain advertising is to offer a reduction from the advertiser's own former price for an article. If the former priced is the actual, bona fide price at which the article was offered to the public on a regular basis for a reasonably substantial period of time, it provides a legitimate basis for the advertising of a price comparison. Where the former price is genuine, the bargain being advertised is a true one. If, on the other hand, the former price being advertised is not bona fide but fictitious - for example, where an artificial, inflated price was established for the purpose of enabling the subsequent offer of a large reduction - the "bargain" being advertised is a false one; the purchaser is not receiving the unusual value he expects. In such a case, the "reduced" price is, in reality, probably just the seller's regular price.

(b) A former price is not necessarily fictitious merely because no sales at the advertised price were made. The advertiser should be especially careful, however, in such a case, that the price is one at which the product was openly and actively offered for sale, for a reasonably substantial period of time, in the recent, regular course of her business, honestly and in good faith – and, of course, not for the purpose of establishing a fictitious higher price on which a deceptive comparison might be based.

- 22 || (16 C.F.R. § 233.1(a) & (b) (italics added).)
 - 70. In addition to federal law, California law also expressly prohibits false former pricing
- 24 schemes. California's FAL, Business and Professions Code section 17501, entitled "Worth or value;
- 25 statements as to former price," states:
- For the purpose of this article the worth or value of any thing advertised is the prevailing market price, wholesale if the offer is at wholesale, retail if the offer is at retail, at the time of publication of such advertisement in the locality wherein the advertisement is published.
 - No price shall be advertised as a former price of any advertised thing, unless the alleged former price was the prevailing market price as above defined within three months next

immediately preceding the publication of the advertisement or unless the date when the alleged former price did prevail is clearly, exactly and conspicuously stated in the advertisement.

(Bus. & Prof. Code, § 17501 (italics added).)

71. As detailed in Plaintiff's Third Cause of Action below, the CLRA, Civil Code section 1770(a)(9), prohibits a business from "[a]dvertising goods or services with intent not to sell them as advertised," and subsection (a)(13) prohibits a business from "[m]aking false or misleading statements of fact concerning reasons for, existence of, or amounts of price reductions."

72. As detailed herein, the acts and practices alleged were intended to or did result in violations of the FTCA, the FAL, and the CLRA.

73. Defendants' practices, as set forth above, have misled Plaintiff, the proposed Class, and the public in the past, and will continue to mislead in the future. Consequently, Defendants' practices constitute an unlawful, fraudulent, and unfair business practice within the meaning of the UCL.

74. Defendants' violation of the UCL, through their unlawful, unfair, and fraudulent business practices, are ongoing and present a continuing threat that Class members and the public will be deceived into purchasing products based on price comparisons of arbitrary and inflated "reference" prices and substantially discounted "sale" prices. These false comparisons created phantom markdowns and led to financial damage for consumers like Plaintiff and the Class.

75. Pursuant to the UCL, Plaintiff is entitled to preliminary and permanent injunctive relief and an order for Defendants to cease this unfair competition, as well as disgorgement and restitution to Plaintiff and the Class of all Defendants' revenues associated with their unfair competition, or such portion of those revenues as the Court may find equitable.

SECOND CAUSE OF ACTION

Violation of California's False Advertising Law ("FAL") Business and Professions Code section 17500 et seq.

76. Plaintiff repeats and re-alleges the allegations contained in every preceding paragraph as if fully set forth herein.

77. The Business and Professions Code section 17500 provides:

CLASS ACTION COMPLAINT

It is unlawful for any...corporation...with intent...to dispose of...personal property...to induce the public to enter into any obligation relating thereto, to make or disseminate or cause to be made or disseminated...from this state before the public in any state, in any newspaper or other publication, or any advertising device, or by public outcry or proclamation, or in any other manner or means whatever, including over the Internet, any statement...which is <u>untrue or misleading</u>, and which is known, or which by the exercise of reasonable care should be known, to be untrue or misleading..."

|| (Italics added.)

78. The "intent" required by section 17500 is the intent to dispose of property, and not the intent to mislead the public in the disposition of such property.

79. Similarly, this section provides:

no price shall be advertised as a former price of any advertised thing, unless the alleged former prices was the prevailing market price...within three months next immediately preceding the publication of the advertisement or unless the date when the alleged former price did prevail is clearly, exactly, and conspicuously stated in the advertisement.

12 || (Bus. & Prof. Code, § 17501.)

80. Defendants' routine of advertising discounted prices from false "reference" prices, which
were never the prevailing market prices of those products and were materially greater than the true
prevailing prices (i.e., Defendants' actual sale price), was an unfair, untrue, and misleading practice. This
deceptive marketing practice gave consumers the false impression that the products were regularly sold on
the market for a substantially higher price than they actually were, therefore, leading to the false impression
that the products sold on Defendants' e-commerce website were worth more than they actually were.

19

20

81. Defendants misled consumers by making untrue and misleading statements and failing to disclose what is required by the Code, as alleged above.

82. As a direct and proximate result of Defendants' misleading and false advertisements,
Plaintiff and Class members have suffered injury in fact and have lost money. As such, Plaintiff requests
that this Court order Defendants to restore this money to Plaintiff and all Class members, and to enjoin
Defendants from continuing these unfair practices in violation of the UCL in the future. Otherwise,
Plaintiff, Class members, and the broader general public, will be irreparably harmed and/or denied an
effective and complete remedy.

10	purchased by Plaintiff and the Class are "goods" within the meaning of Civil Code section 1761,					
11	subdivision (a).					
12	85. Defendants violated, and continue to violate, the CLRA by engaging in the following					
13	practices proscribed by Civil Code section 1770, subdivision (a) in transactions with Plaintiff and the Class					
14	which were intended to result in, and did result in, the sale of merchandise sold on its e-commerce website:					
15	(13) Making false or misleading statements of fact concerning reasons for, existence of, or					
16	amounts of price reductions.					
17	86. Pursuant to section 1782, subdivision (a) of the CLRA, on February 16, 2023, Plaintiff's					
18	counsel notified Defendant Nogin, Inc., in writing by certified mail of the particular violations of section 1770					
19	of the CLRA, and demanded that it rectify the problems associated with the actions detailed above and give					
20	notice to all affected consumers of Defendants' intent to act. Defendant Nogin, Inc., failed to respond					
21	appropriately to Plaintiff's letter, nor did it agree to rectify the problems associated with the actions detailed					
22	above and give notice to all affected consumers within 30 days of the date of written notice, as prescribed					
23	by section 1782. Therefore, Plaintiff further seeks claims for actual, punitive and statutory damages, as					
24	appropriate against Defendant Nogin, Inc					
25	87. Plaintiff intends to send similar notices pursuant to section 1782, subdivision (a) of the					
26	CLRA to Defendants Bluestar Alliance, LLC, Justice Brand Holdings, LLC, Defendant B. Riley Securities,					
27	Inc., and B. Riley Principal Investments, LLC, no later than December 1, 2023. If these Defendants fail to					
28	respond to Plaintiff's letter, fail to agree to rectify the problems associated with the actions detailed above,

1	or fail to give notice to all affected consumers within 30 days of the date of written notice, as prescribed
2	by Section 1782, Plaintiff will move to amend this Complaint to pursue claims for actual, punitive, and

4	seeks only equitable restitution and injunctive relief.
5	Filed concurrently herewith is a declaration of venue pursuant to CAL. CIV. CODE §1780(d).

7	Wherefore, Plaintiff, on behalf of herself and on behalf of the other members of the Class, requests
8	that this Court award relief against Defendants as follows:
9	a. an order certifying the Class and designating Plaintiff as the Class Representative
10	and her counsel as Class Counsel;
11	b. awarding Plaintiff and Class members actual, consequential, punitive and statutory
12	damages, as appropriate;
13	c. awarding restitution and disgorgement of all profits and unjust enrichment that
14	Defendants obtained from Plaintiff and the Class members as a result of its unlawful, unfair, and
15	fraudulent business practices described herein;
16	d. awarding declaratory and injunctive relief as permitted by law or equity, including:
17	enjoining Defendants from continuing the unlawful practices as set forth herein, and directing
18	Defendants to identify, with Court supervision, victims of their misconduct and pay them all money
19	they are required to pay;
20	e. order Defendants to engage in a corrective advertising campaign;
21	f. awarding attorneys' fees and costs; and
22	g. for such other and further relief as the Court may deem necessary or appropriate.
